- 1. Meeting called to order by Chief Craig Olson at 6:00 PM.
- 2. Notice given to the Village Hall and posted on the department website (campbellsportfire.com)
- 3. Roll call 13 present; 6 absent
- **4.** A motion to accept the minutes from the December 2017 Officer meeting was made by **Bill Grede**, second by **Jeff Twohig**. Motion approve (voice vote)
- **5.** Thought safety went well at the house fire on NYE. Only downside was how far rehab was, but options were limited
- **6.** PE-nothing
- 7. There were quite a few radios purchased, from this years and last years budgeted funds. It should allow us to communicate with Sheboygan's Fire and EMS. Questions were raised on our radios, if something can be done as many officers have questioned how well radios have been working lately. **Jackie Batzler** is now 422
- **8.** Chief would like worklists generated for the engineers
- **9.** Refresher is still going on. There will not be any more scheduled refreshers monthly practice will go towards those hours. TIME training is scheduled for next Monday.
- 10. Chief showed the rough draft of the vehicle response board which will be purchased soon
- **11.** FEMA grant priority guidelines do not go well with getting backup sets of gear. Will be looking for assistance with writing the grant. Other options have been air scrubbers and diesel exhaust systems
- 12. New captain crews have been assigned
- **13. Chief** discussed his goals for captain crews and the upcoming years for crews. Guidelines were passed around. Chief wants to implement in February.
 - **Bill Grede** said he was going to mandate that all EMS attend the Saturday ice dive practice.
